2025 Extraordinary General Assembly

At the request of the acting IPF President Sigurjón Pétursson and in accordance with Articles 6.3.2. and 6.3.3 of the IPF Constitution an Extraordinary General Assembly (EGA) meeting is hereby scheduled to take place at the date, time, and place set out immediately below:

The Extraordinary General Assembly will be conducted in hybrid form. Those that cannot attend in person can participate on-line. Further instructions on how to connect, take part and vote on-line will be sent to you at a later date.

This Extraordinary General Assembly is being held because Gaston Parage resigned as IPF President on March 10, 2025. Following [IPF Constitution Article 7.2](#), IPF Vice President Sigurjón Pétursson assumed the role of Acting IPF President until the next General Assembly. Similarly, IPF Treasurer Dietmar Wolf was appointed Acting IPF Vice President. Since these are temporary positions, member federations need to elect a new IPF President and IPF Vice President for the remainder of the term, ending in 2027. Therefore, the EGA will be voting on candidates for the next two years only.

If Acting IPF President Sigurjón Pétursson runs for the position of president and is elected, then the EGA will need to elect a new IPF Vice President. If Sigurjón Pétursson is not elected as IPF President and another candidate is chosen, he will return to his role as IPF Vice President. The same applies to the position of IPF Vice President. If Sigurjón Pétursson is not elected as the new IPF president, acting IPF vice president Dietmar Wolf will return to his position as IPF treasurer. If Sigurjón Pétursson is elected as IPF president and Dietmar Wolf runs for the IPF Vice President position and is elected, then the EGA will need to elect a new IPF Treasurer. If Dietmar Wolf is not elected as the new IPF Vice President, he will resume his position as IPF Treasurer.

Given the circumstances, the IPF Member Federations can nominate candidates for the positions of president, vice president, and treasurer.

All nominations must be received from Member Federations no later than Wednesday April 30, 2025, at 23:59 CET. All nominated candidates will be posted on the IPF Website no later than Monday, May 10, 2025, at 23:59 CET.
